Section 4 - First Aid Measures

Section 6 - Accidental Release Measures

Accidental release: Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Stop leak if safe to do so, and contain spill. Sweep up and shovel or collect recovered product into labelled containers for recycling or salvage, and dispose of promptly. After spills, wash area preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency services. This material may be suitable for approved landfill. Ensure legality of disposal by consulting regulations prior to disposal. Thoroughly launder protective clothing before storage or re-use. Advise laundry of nature of contamination when sending contaminated clothing to laundry.

Section 7 - Handling and Storage

Handling: Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. Storage: Store in cool, dry area removed from foodstuffs. Ensure containers are labelled, protected from physical damage and sealed when not in use. Do not allow to come into contact with water either from rain, condensation or the surface on which it is stored. Bagged fertilisers should be stored under cover and out of direct sunlight. Store away from farm chemicals e.g. insecticides, fungicides and herbicides.
