## Section 4 - First Aid Measures

### General Information:

**Fire and Explosion Hazards:** There is no risk of an explosion from this product under normal circumstances if it is involved in a fire. May evolve ammonia, sulphur and oxides of nitrogen, phosphorus, Chloride and potassium when heated to decomposition.

## Section 6 - Accidental Release Measures

**Accidental release:** In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Stop leak if safe to do so, and contain spill. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage. After spills, wash area preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency services. Full details regarding disposal of used containers, spillage and unused material may be found on the label. ## Section 7 - Handling and Storage

No special storage and transport requirements. This product has no UN classification.

**Handling:** Check Section 8 of this MSDS for details of personal protective measures, and make sure that those measures are followed. The measures detailed below under "Storage" should be followed during handling. Also, avoid contact or contamination of product with incompatible materials listed in Section 10.

**Storage:** Store in a cool, dry place away from children and animals or foodstuffs. Ensure containers are labelled, protected from physical damage and sealed when not in use. Do not allow to come into contact with water either from rain, condensation or the surface on which it is stored. Bagged fertilisers should be stored under cover and out of direct sunlight. High stacking should be avoided as pressure promotes caking. Store away from farm chemicals eg insecticides, fungicides and herbicides. This product when stored in a confined, unventilated space can give off ammonia or other odour and lead to the depletion of oxygen within this space and other confined areas. Keep from extreme heat and open flames, and make sure that the product does not come into contact with substances listed under "Materials to avoid" in Section 10.
