
## 2 Hazard(s) Identification

#### Hazardous Nature:

## 3 Composition and Information on Ingredients

### Methods and Materials for Containment and Cleaning Up:

Stop leak if safe to do so and absorb spill with sand, earth, vermiculite or some other absorbent material. Collect the spilled material and place into a suitable container for disposal.

# 7 Handling and Storage

## Precautions for Safe Handling:

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of vapours or mists.
