Section 4 - First Aid Measures

Section 6 - Accidental Release Measures

Accidental release: This product is sold in small packages and the accidental release from one of these is not usually a cause of concern. Wear elbow length rubber gloves, eye protection and disposable respiratory mask. For minor spills, clean up, rinsing to sewer and put empty container in garbage. In the event of a major spill, prevent spillage from entering drains or water courses and call emergency services.

Section 7 - Handling and Storage

Handling: Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. Check Section 8 of this SDS for details of personal protective measures, and make sure that those measures are followed. The measures detailed below under "Storage" should be followed during handling in order to minimise risks to persons using the product in the workplace. Also, avoid contact or contamination of product with incompatible materials listed in Section 10. Observe good personal hygiene, including washing hands before eating. Prohibit eating, drinking and smoking in contaminated areas.

Storage: Store in cool, dry area removed from foodstuffs. Ensure containers are labelled, protected from physical damage and sealed when not in use. Make sure that the product does not come into contact with substances listed under "Incompatibilities" in Section 10.

Section 8 - Exposure Controls and Personal Protection

Exposure limits have not been set for any other ingredients in product. The STEL (Short Term Exposure Limit) is an exposure value that should not be exceeded for more than 15 minutes and should not be repeated for more than 4 times per day.
