## Section 2 - Hazards Identification

## **Statement of Hazardous Nature**

This product is classified as: Xi, Irritating. N, Dangerous to the environment. Hazardous according to the criteria of SWA.

Not subject to the ADG Code when transported in Australia by Road or Rail in packages 500kg(L) or less; or IBCs (refer to SP AU01). ## **Emergency Overview**

**Physical Description & Colour**: Off white to tan water dispersible granules.

Odour: No distinct odour.

Major Health Hazards: eye irritant.

### **Potential Health Effects**

#### Inhalation:

**Short Term Exposure:** Available data indicates that this product is not harmful. However product may be mildly irritating, although unlikely to cause anything more than mild transient discomfort.

## Section 4 - First Aid Measures

#### **General Information:**

## **Section 5 - Fire Fighting Measures**

**Fire and Explosion Hazards**: The major hazard in fires is usually inhalation of heated and toxic or oxygen deficient (or both), fire gases.
