## Section 4 - First Aid Measures

**General Information:** You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. ## Section 6 - Accidental Release Measures

**Accidental release:** If material is spilled, keep unauthorised personnel away, isolate hazard area and avoid contact with spilled product. As a minimum, wear overalls, goggles and gloves. Suitable materials for protective clothing include rubber, PVC. Eye/face protective equipment should comprise as minimum, protective glasses and, preferably, goggles. If there is a significant chance that vapours or mists are likely to build up in the cleanup area, we recommend that you use a respirator.

In the event of a major spill, prevent spillage from entering drains or water courses. Stop leak if safe to do so, and contain spill. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage. After spills, wash area preventing runoff from entering drains. ## Section 7 - Handling and Storage

Classified as a Class 2 Combustible Liquid for the purposes of storage and handling.

**Handling:** Check Section 8 of this MSDS for details of personal protective measures, and ensure that those measures are followed. ## Section 8 - Exposure Controls and Personal Protection

Exposure limits have not been set for ingredients in product. The TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. There is a blanket limit of 10mg/m<sup>3</sup> for dusts or mists when limits have not otherwise been established. The STEL (Short Term Exposure Limit) is an exposure value that should not be exceeded for more than 15 minutes and should not be repeated for more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly. ADI means Acceptable Daily Intake and NOEL means No-observable-effect-level. Values taken from Australian ADI List, 31<sup>st</sup> March 2012

### Personal Protection
