This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

### **Section 4 - First Aid Measures**

#### **General Information:**

## **Section 5 - Fire Fighting Measures**

**Fire and Explosion Hazards**: The major hazard in fires is usually inhalation of heated and toxic or oxygen deficient (or both), fire gases. There is no risk of an explosion from this product under normal circumstances if it is involved in a fire. Violent steam generation or eruption may occur upon application of direct water stream on hot liquids. Vapours from this product are heavier than air and may accumulate in sumps, pits and other low-lying spaces, forming potentially explosive mixtures. They may also flash back considerable distances.

Fire decomposition products from this product may be toxic if inhaled. Take appropriate protective measures.

## Section 6 - Accidental Release Measures

Accidental release: Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Suitable materials for protective clothing include rubber. Eye/face protective equipment should comprise as a minimum, protective glasses and, preferably, goggles. If there is a significant chance that vapours or mists are likely to build up in the cleanup area, we recommend that you use a respirator. Usually, no respirator is necessary when using this product. However, if you have any doubts consult the Australian Standard mentioned below (section 8). Stop leak if safe to do so, and contain spill. Absorb onto sand, vermiculite or other suitable absorbent material. #### **Potential Health Effects**

#### Inhalation:

**Short term exposure:** Available data indicates that this product is not harmful. In addition product is unlikely to cause any discomfort or irritation.

**Environmental Toxicology:** Essentially non toxic to bees (48hr  $LC_{50} > 200 \mu g/bee$ ) and earthworms (14 day  $LC_{50} > 1000 \text{ ppm}$ ).

**Environmental Fate:** di-1-p-menthene, the active ingredient in this product is degraded in soils by micro organisms in approximately 15 days. However, it is not readily degradable in water and is partly soluble in water. It may cause long term adverse effects in aquatic environments. It has no inhibitory effects to sewage micro organisms.
