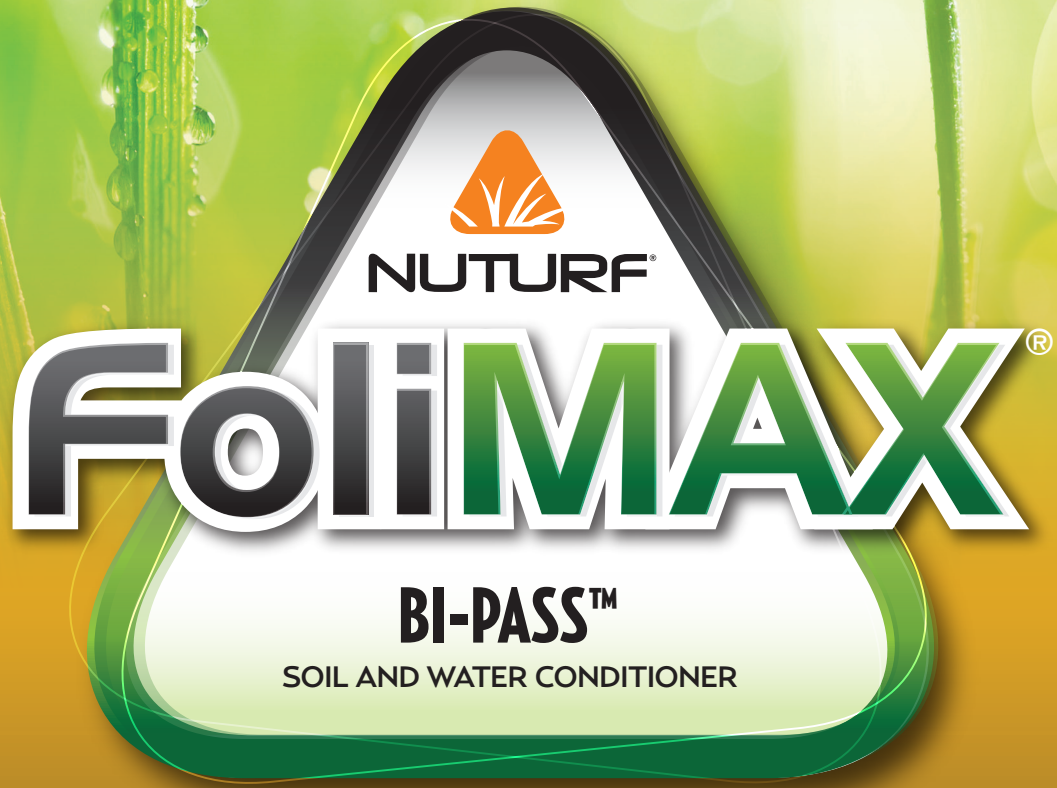

DIRECTIONS FOR USE:

Apply FoliMAX Bi-Pass™ through a boom spray at regular intervals to reduce the impact of bicarbonate within the soil profile. Apply in a minimum of 200L water per hectare and follow with 4–6mm irrigation. Do not apply when temperatures exceed 30°C. Alternatively FoliMAX Bi-Pass™ can be applied directly as a dose treatment to the irrigation water to reduce the impact of bicarbonate and carbonate and reduce the occurrence of scale build up in irrigation lines.

Application Rate Chart		
Situation	Rate	Comments
Initial Application: Fine Cut & High Cut Turf	4 – 5 L / Ha	Apply at 4–8 week intervals or as recommended by your Territory Manager.
Maintenance Application: Fine Cut & High Cut Turf	2 – 5 L / Ha	
As a descaling agent in irrigation lines	1 L per 100 L to 1,000 L	Apply through an injection or dosing unit directly into irrigation lines. Target pH under 3 for a minimum of 3 hours. Rate dependent on water analysis results, seek advice from your Territory Manager.

MIXING & COMPATIBILITY:

Fill spray vessel with half the required volume of water. Shake container of FoliMAX Bi-Pass™ and add required amount to spray tank while agitating. Add remaining water to the spray tank. Continue agitating during application. Wash out spray tank, including nozzles, immediately after use. Always perform a jar test prior to undertaking any tank mixes for the first time.

STORAGE, HANDLING AND DISPOSAL:

Do not store below 0°C or above 50°C, as crystallisation may occur. Do not contaminate lakes, streams, dams or ponds by cleaning equipment or disposal of waste. Avoid contact with eyes and skin by wearing appropriate protective equipment, such as gloves, boots and safety goggles.

FIRST AID AND SAFETY DIRECTIONS:

In case of contact with eyes or skin, flush at once with large amounts of water. If irritation persists, seek medical attention. If swallowed, drink large amounts of water and induce vomiting. Seek medical attention.
