Section 4 - First Aid Measures

General Information:

Eye Contact: Immediately flush the contaminated eye(s) with lukewarm, gently flowing water for 5 minutes or until the product is removed, while holding the eyelid(s) open. Section 7 - Handling and Storage

Handling: Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. In mammals, clofentezine undergoes metabolism by hydroxylation and exchange of the chlorine atoms on the rings for a methylthio group. Following oral administration, excretion occurs within 24-48 hours in urine and faeces. **In plant** metabolism studies, unchanged clofentezine was the major extractable residue. Small quantities (4%) of 2-chlorobenzonitrile, the major photodegradation product, was also detected.

In soil, the major degradation route leads to 2-chlorobenzoic acid, and thence to carbon dioxide. DT50 in soil is 65-80 days at 15°C, 28-56 days at 25°C, depending on soil type. However, in laboratory studies, no leaching occurs. In water, 2-chlorobenzonitrile is the major product formed by hydrolysis and photodegradation, with smaller amounts of other compounds. Low solubility in water makes determination of soil adsorption values difficult.

Section 13 - Disposal Considerations

Disposal: Instructions concerning the disposal of this product and its containers are given on the registered label. These should be carefully followed.
