## Section 4 - First Aid Measures

### Section 6 - Accidental Release Measures

Accidental release: For minor spills, clean up, rinsing to sewer and put empty container in garbage. Store away from farm chemicals e.g. insecticides, fungicides and herbicides.

Exposure limits have not been set by SWA for any ingredients in product.
