TaserPRO[®] 800 WP is a residual broad spectrum NON-REPELLENT spray for control of a wide range of insect pests in domestic, farm, agricultural, industrial, commercial and public service buildings.

Potent active ingredient

New Taser[®]PRO contains the powerful active ingredient bendiocarb in a highly concentrated 800 g/kg wettable powder formulation.

TaserPRO - use with great confidence

TaserPRO is a non-repellent insecticide with the broadest pest claims on the Australian market. This makes TaserPRO an essential tool in the professional pest managers arsenal. Once mixed in the tank, TaserPRO is a non-scheduled poison making it very versatile in its use pattern.

TaserPRO can be applied to any surface which is not damaged by water alone. TaserPRO will remain active for many weeks at the normal rate and greater residuality will be achieved at the special rate.

The residual life of the deposit will vary depending upon the cleanliness and nature of the surface to which it is applied. Therefore re-treat as necessary. TaserPRO treated premises can be re-occupied by children, pets and other animals once the sprayed surfaces are dry.

TaserPRO is odourless which makes it ideal for use in sensitive areas where strong odours may cause problems.

TaserPRO - very effective at controlling a variety of pests

TaserPRO is highly effective against a broad range of pest species including but not limited to ants, bed bugs, carpet beetles, cockroaches, fleas, spiders, silverfish, black Portuguese millipedes, European wasps, flies (common housefly, stable fly, brown blowfly, European green blowfly, and lesser housefly), seed harvesting ants, and African black beetle. This makes TaserPRO the most comprehensive non-repellent formulation available.



TaserPRO - breaks resistance

Resistance in cockroaches has been recorded in Australia. Resistance has increased over the years. At the heart of TaserPRO is the carbamate insecticide bendiocarb. TaserPRO is an ideal rotational product for synthetic pyrethroids (such as bifenthrin) as well as an essential tool of an integrated pest management approach. TaserPRO can be used in rotation with pyrethroids to limit pest resistance issues. Research demonstrates the use of different chemical groups will reduce the risk of resistance developing.

TaserPRO - contains bendiocarb (carbamate)

TaserPRO has long lasting activity as bendiocarb is photo-stable and will not be absorbed by porous surfaces thus enhancing particle availability to be contacted by insects.

Being a wettable powder with distribution of larger sized particles gives TaserPRO excellent residual action for longer pest eradication.

TaserPRO - water dispersible powder formulation

TaserPRO contains an inbuilt wetting agent which works on porous and non-porous surfaces without the need to handle different products. It does not cause skin irritation and is therefore very friendly for user and end customer.

Like many wettable powder formulations, TaserPRO may leave some visible deposits on certain glossy surfaces. You should always consider the surface and the impact of the potential for visible residues prior to use.

Where a surface may be susceptible to damage or staining, it is recommended that a small inconspicuous area be treated (and allowed to dry) before large scale application.

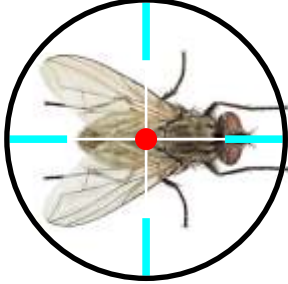

TaserPRO and fly control

TaserPRO is highly effective against a broad range of fly species including common house fly, stable fly, brown blowfly, European green blowfly and lesser housefly. Mix 15 g of TaserPRO in 5 litres of water with the addition of 50g of sugar dissolved into the mix. Identify where flies settle and spray the surface. The sugar acts as a bait encouraging flies to remain on the treated surface long enough to pick up a lethal dose of insecticide.



TaserPRO - areas for use

Food processing factories, restaurants, laundries, food stores, ships, hospitals, kitchens, boiler houses, private dwellings, canteens, hotel-motels, in and around farm buildings, abattoirs, garbage containers and dumps, manure heaps, or other places where flies rest or breed. Wasp nests. Pasture seed treatment. Turf: Golf greens and fairways, bowling greens and playing fields.
