Section 4 - First Aid Measures

General Information: You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 13 1126 from anywhere in Australia (0800 764 766 in New Zealand) and is available at all times. Have this SDS with you when you call.

Inhalation: Inhalation has occurred, and irritation has developed, remove to fresh air and observe until recovered. If irritation becomes painful or persists more than about 30 minutes, seek medical advice.

Skin Contact: A small amount of skin contact is not normally harmful. Gently brush away excess particles. Wash gently and thoroughly with water (use non-abrasive soap if necessary) for 5 minutes or until chemical is removed.

Eye Contact: Quickly and gently brush particles from eyes. No effects expected. Section 6 - Accidental Release Measures

Accidental release: If spilt, wear dust proof goggles, gloves and respirator (where dust inhalation risk exists) and ventilate spillage area. Collect and place in sealable containers for disposal. Avoid generating dust. For minor spills, clean up, rinsing to sewer and put empty container in garbage. In the event of a major spill, prevent spillage from entering drains or water courses and call emergency services.

Section 7 - Handling and Storage

Handling: Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. Check Section 8 of this SDS for details of personal protective measures, and make sure that those measures are followed. The measures detailed below under "Storage" should be followed during handling in order to minimise risks to persons using the product in the workplace. Also, avoid contact or contamination of product with incompatible materials listed in Section 10. Observe good personal hygiene, including washing hands before eating. Storage: Store in cool, dry area removed from foodstuffs. Ensure containers are labelled, protected from physical damage and sealed when not in use. major ingredients in this product. There is a blanket limit of 10mg/m³ for dusts or mists when limits have not otherwise been established. The nature of this product makes it unlikely that this level will be approached in normal use. ADI means Acceptable Daily Intake and NOEL means No-observable-effect-level.
