### PRODUCT INFORMATION

Umbrella 905 is a multipurpose spray adjuvant designed to extend the life of foliar applied pesticides and fertilisers in agricultural, horticultural & turf situations.

Umbrella 905 forms a rain fast film over the applied pesticide solution, securing it onto the leaf, reducing environmental losses and enhancing application efficacy.

Umbrella 905 also optimises spreading and surface coverage on hard to wet plant surfaces, further improving application results.

In agriculture, Umbrella 905 will assist in retaining yield potential in crops prone to pod shatter.

#### **Application Information**

Umbrella 905 is an extender sticker spreader agent designed to control the life of pesticides. It is compatible in the spray tank with pesticides and fertilisers. Under most conditions, apply sprays containing Umbrella 905 with at least one hour of daylight, or before anticipated rain.

One hour of sunlight is needed for the protective film to set. Umbrella 905 has the ability to allow secondary applications to penetrate through the set layer.

#### **Mixing Instructions**

Add Umbrella 905 to the spray tank as the last ingredient. Rinse tank, lines and nozzles, immediately after spraying with water. After rinsing, there may still be a small amount of sticky residue in the tank. This will help to prevent rusting and corrosion. It will not clog nozzles when sprayer is next used.

If spray happens to hit non-target surfaces, it can be removed with soap and water. If dried or set, use premium grade kerosene to remove residue.
