Vantage Fungicide is a



member of the strobiluron and related products group of fungicides. For fungicide resistance management the product is a Group 11 fungicide. Some naturally occurring individual fungi resistant to the product and other Group 11 fungicides may exist through normal genetic variability in any fungal population. The resistant individuals can eventually dominate the fungal population if these fungicides are used repeatedly. These resistant fundi will not be controlled by this product or other Group 11 fungicides, thus resulting in a reduction in efficacy and possible yield loss. Since the occurrence of resistant fungi is difficult to detect prior to use, Amgrow Pty Ltd accepts no liability for any losses that may result from the failure of Vantage Fungicide to control resistant fungi.

Resistance Management

Disease control may be reduced if strains of pathogens less sensitive to Vantage develop. Vantage is best used in a preventative disease control program. Reliance on curative use of Vantage could lead to resistance.

As a precaution, DO NOT apply Vantage for more than a total of 1/3 of the fungicide applications in one season. If consecutive applications of Vantage are used they must be followed by at least the same number of applications of fungicide(s) from a different group(s) before Vantage is used again in the current or following season.

WARNING

Vantage Fungicide is extremely phytotoxic to certain apple varieties. DO NOT spray Vantage Fungicide where spray drift may reach apple trees. DO NOT spray when conditions favour drift beyond the area intended for application. Conditions that may contribute to drift include thermal inversions, excessive wind speed, certain sprayer nozzle/ pressure combinations, small spray droplet size, etc.

COMPATIBILITY/TANK MIXING

Vantage is physically compatible with a wide range of products, however the biological compatibility of these mixtures may not have been fully tested under all environmental and biological conditions.

A mixture of Vantage Fungicide with any other product may in some circumstances be ineffective or may cause damage. If tank mixes are to be used observe all directions. precautions and limitations on all products to be used. As formulations of other manufacturer's products are beyond the control of Amgrow, and the quality of water may vary with location, all mixtures should be tested prior to mixing commercial quantities.

MIXING

Add the required amount of product directly to the spray tank and mix well. Vantage Fungicide is a dispersible concentrate formulation with minimal odour, as the product does not contain petroleum solvents. Vantage Fungicide forms a micro-emulsion on dilution with water and may be tank mixed with many commonly used fungicides and liquid fertilisers.

APPLICATION

Ensure even application in order to achieve even disease control. Avoid overlapping sprays.

Leaf and Crown Diseases: Application volume for leaf and crown diseases (Anthracnose, Brown Patch, Grey Leaf Spot, Helminthosporium diseases, Pythium Blight, Red Thread and Winter Fusarium) should be adequate to ensure thorough and even coverage of the turf leaves and penetration to the crowns. Ideal application volume should be 350 to 500 L/ha. For best results use medium [XR Teejet* (11004 or 10005)] to coarse [Turbo Teejet* or AIXR Teejet* (11004 or 11005)] nozzles, at 5 km/h and 3 bar pressure. In higher cut turf (≥15 mm) a significant spray shielding effect can occur, impacting negatively on spray penetration and even coverage at low application volumes. Root Diseases: Application volumes for root infecting diseases (Brown Patch and Pythium Root Rot) should be as high as possible (approximately 1000 L/ha) to ensure placement close to the soil surface. When lower application volumes are used, washing in should commence as soon as possible after application. For best results use extremely coarse droplets [Turbo Floodjet (TF5) or TurfJet* (TTJ10)] and total application volume of approximately 1000 L/ha. Preferably spray onto wet or dewy grass. Irrigate with 6 to 10 mm of water commencing within 1 hour of application. Apply in a sufficient volume of water to achieve thorough coverage of all foliage. In turf this can generally be achieved with spray volumes of 4 to 8 L per 100 m².
